#### I. CONSISTENCY OF BUSINESS PLAN WITH COUNTRY PARTNERSHIP STRATEGY

- 1. The country partnership strategy (CPS), 2013–2017¹ of the Asian Development Bank (ADB) for the Kyrgyz Republic supports the National Sustainable Development Strategy, 2013–2017.² The government has started developing its new strategy for 2018–2022 and the long-term vision for 2040. The strategic thrust of the COBP, 2018-2020 remains aligned with the priorities of the CPS, 2013–2017, but the pipeline for 2019–2020 will be reviewed once the new CPS, 2018–2022 is endorsed. ADB will continue to support (i) public sector management for private sector development; (ii) transport and logistics, focusing on the rehabilitation of regional corridors and maintenance of the road network; (iii) the energy sector, focusing on rehabilitating and upgrading a major hydropower plant, and institutional and technological reform to improve sector efficiency; (iv) education and training, focusing on improvement of the availability and quality of a skilled workforce, and employability of the population; and (v) water supply and sanitation, responding to the government's request and commitment to sector reform.
- 2. Consultations with the government during April–May 2017 confirmed the rationale for an enhanced COBP process to bridge the gap between the CPS, 2013–2017 and future CPSs.<sup>3</sup> The government broadly confirmed the prioritized operational program presented in this COBP.

#### II. INDICATIVE RESOURCE PARAMETERS

3. The Kyrgyz Republic, a group A developing member country, is eligible for Asian Development Fund (ADF) grants and concessional ordinary capital resources lending (COL). The indicative ADF grant and COL resource allocation for 2018–2020 is \$299.5 million, including \$30 million from disaster risk reduction (DRR) operations. Cofinancing and funding from other sources, including the regional pool under concessional resources, will be explored. The 2016 debt distress classification of the Kyrgyz Republic was assessed to be at moderate risk of debt distress. In accordance with the ADF grants framework, the country is to receive 50% of its country allocation in grants in 2017, subject to a 20% volume discount on the grant portion of the country allocation. The indicative firm lending program for 2018–2020 is planned for \$343.8 million and is subject to project readiness, and the nonlending program for \$5.3 million of technical assistance (TA) grants. The final allocation will depend on available resources and the outcome of the country performance assessment. The private sector may access ADB's ordinary capital resources (OCR) for projects, which may include lending to key sectors such as energy, transport and logistics, and finance.

#### III. SUMMARY OF CHANGES TO LENDING AND NONLENDING PROGRAMS

4. The results framework attached to the COBP, 2017–2019 has been updated (Appendix 1). The updated lending and nonlending program for 2018–2020 (Appendix 2), the lending and nonlending program for 2017 (Appendix 3), and the list of indicative knowledge publications and events for 2018 (Appendix 4) are as follows.

- 5. **Public sector management for better investment climate.** Financing for the Rural Financial Inclusion Project, planned for 2018, increased from \$10 million to \$20 million (with possible cofinancing of \$10 million). The project will help improve rural income generation and livelihoods via the provision of credit lines to support enterprises operating in the agriculture value chain. The Second Investment Climate Improvement Program, subprogram 3, for \$25 million, advanced from 2018 to 2017, will support reforms for creating an enabling environment for private sector development. ADB will support knowledge products for (i) creating more awareness and understanding of public—private partnerships, and (ii) helping effective utilization of the national credit guarantee fund.
- 6. **Transport and logistics.** The Central Asia Regional Economic Cooperation (CAREC) Corridors 1 and 3 Connector Road Project (additional financing), is delayed from 2017 to 2018, with decreased financing from \$73 million to \$68 million. The project will focus on road safety, asset management, and maintenance. In 2019, the CAREC Corridor 3 Improvement Project (additional financing), with decreased financing from \$22 million to \$18.9 million (with possible cofinancing of \$31.1 million), will rehabilitate the Bishkek northern bypass road. A new \$20 million Road Maintenance Project is planned for 2020. ADB will support knowledge products by assisting the government in (i) road sector reform, (ii) designing and implementing a pilot road asset management system, and (iii) conducting a road safety campaign.
- 7. **Energy sector.** In 2019, the Energy Sector Project with increased financing from \$45 million to \$50 million (with possible cofinancing of \$100 million) will rehabilitate the Uch-Kurgan hydropower plant and will continue energy sector reforms. ADB will assist in preparing (i) an energy sector development master plan, (ii) a dam safety study of Naryn cascade hydropower plants, (iii) asset inventory and revaluation of the power companies, and (iv) comprehensive Enterprise Resource Planning systems. The master plan will guide ADB's future support in the sector.
- 8. **Education and training.** The Skilling and Entrepreneurship for Inclusive Growth Project for \$30 million, advanced from 2018 to 2017, will focus on the quality of vocational education, governance, and education financing. The project will support (i) post-secondary curricula reform in technical and vocational education, (ii) the introduction of entrepreneurship education, and (iii) in-service teacher training. In 2020, a new \$30 million Post-Secondary and Higher Education Sector Reform Program will continue reforms in the education sector.
- 9. **Water supply and sanitation**. The Issyk-Kul Sustainable Development Project, Phase 2, with decreased financing from \$32 million to \$30.5 million (with possible cofinancing of \$11.5 million), is delayed from 2017 to 2018. The project will rehabilitate wastewater treatment plants in Cholpon-Ata, Balykchy, and Karakol. The Second DRR Project for \$30 million (including \$20 million from the DRR), planned for 2020, will focus on landslides mitigation.
- 10. The nonlending program for 2017–2020 includes knowledge and support TA for (i) the National Development Strategy in 2017; (ii) the Rural Financial Inclusion Project, Phase 1 in 2018 and Phase 2 in 2020; and (iii) adaptation to membership in the Eurasian Economic Union, Phase 2 in 2018. Transaction TA will help prepare (i) the Energy Sector Project and the Climate Resilience and Disaster Risk Reduction Project in 2017; (ii) the Rural Water Supply and Sanitation Project, the CAREC Corridor 3 Improvement Project (additional financing), and the Promoting the Economic Diversification Program in 2018; and (iii) the Disaster Risk Reduction Project and the Agriculture Development Project in 2019.
